### Request for Quote to paint TAXI on each end of Boeing Drive to FAA requirements

Cameron Park Airport District (CPAD) is seeking firm fixed price proposals for the following labor and material project in support of Cameron Park Airport (O61).

#### Overview:

Project will be at each end of Boeing Drive, Cameron Park Ca, 95682

This project is to provide the labor and material to paint with approved traffic marking paint at each end of Boeing Drive with TAXI to the dimensions required by the FAA as indicated on the attached sketch.

This project will be managed as a construction project per CPAD and applicable procurement regulations.

It is the intent of CPAD to proceed with this RFQ procurement in a timely manner.

This RFQ is for a Firm Fixed Price (FFP) proposal.

#### Scope of Work for this RFQ:

1. Using the provided sketch for overall dimensions, clean the required areas at each end of Boeing Drive for the application of a black base and then layout and paint TAXI in yellow within the blacked out area to the dimensions on the included sketch
2. Provide required traffic control to keep one side of the street open to traffic and prevent spoiling the painted side until it is sufficiently cured.
3. Complete the work in a timely manner to minimize traffic disruption.
4. Clean up the area and dispose of any leftover materials in compliance with El Dorado County waste and hazardous waste regulations.

#### Materials:

Paint:

Paint shall follow CalTrans standard specifications outlined below for traffic paint that will meet pavement delineation requirements for highway construction and maintenance. The yellow traffic paint is to be used in conjunction with glass spheres to produce pavement delineation that is visible during both day and night conditions, the black is to provide a solid background to the yellow lettering.

Composition:

Acrylic Polymer Emulsion to Cal Trans specification PTWB-01R2

The paint binder shall consist of one of the commercial acrylic or styrene/acrylic polymer emulsions described below;

- Dow Chemical, Fastrack HD-21A

- Dow Chemical, Fastrack 3427
- Dow Chemical Fastrack 5408
- Arkema Coating Resins, Encor DT-400
- Arkema Coating Resins, Encor DT-250

**Bidder Qualifications:**

Firms with prior experience with pavement marking  
List at least one recently completed marking project.  
Current contractor's license, workers comp. and liability insurance  
Comply with Davis-Bacon wage requirements

**Proposal Format**

Bidders shall submit their proposal for this RFQ either by mail or email in .pdf format to [manager@cameronparkairport.org](mailto:manager@cameronparkairport.org) Include the total cost with a breakdown, schedule to complete this RFQ, qualifications statement and references.

Selection Criteria:

1. Lowest cost that meets the specified requirements in this RFQ and provides the best value to CPAD.

**Firm Fixed Price:**

Provide a firm fixed price to prepare the deliverables.

**Selection and Award Process**

Review of proposals will begin upon receipt.

Proposals for this RFQ are to be submitted on or before **4pm PST on April 6, 2022**. Late submittals will not be considered.

Proposals will be reviewed against the selection criteria above.

During the course of this RFQ bidders may request clarifications. If during the course of any clarifications, CPAD amends requirements in the RFQ, CPAD will advise each bidder to provide an opportunity to amend their proposal.

Bidders not selected will be notified.

Bids are to be submitted prior to the stated response date and time to be considered. Each bid shall also include a list of any amendments/clarifications issued by CPAD.

Award and Notifications to bidders will be made on or before **April 8, 2021**
